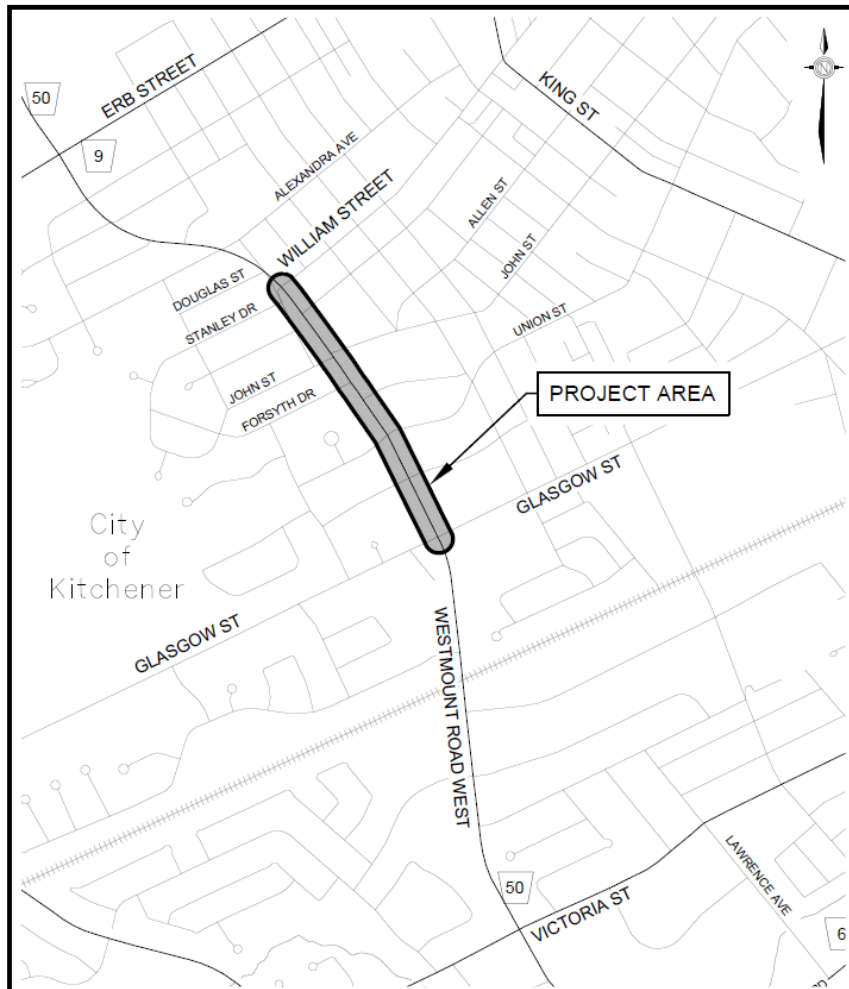
Notice of Public Consultation Centre

Westmount Road

Intersection Improvements

Glasgow Street to William Street Cities of Kitchener and Waterloo

The Region of Waterloo invites you to attend a Public Consultation Centre for the **Westmount Road (Regional Road 50) Intersection Improvements Project** in the Cities of Kitchener and Waterloo. The Study Area includes Westmount Road from William Street to Glasgow Street where roadway improvements are tentatively scheduled to be completed in 2022 and 2023 in the Region's Transportation Capital Program. The scope of work includes rehabilitation of the existing roadways, transit improvements, turn lane improvements, traffic signals, street lighting and landscaping.



All interested parties are invited to attend an informal “drop-in” Public Consultation Centre (PCC) for this project as follows:

The intent of this PCC is to provide you with an opportunity to provide input on the preferred design and improvements planned on Westmount Road from William Street to Glasgow Street. Plans and other project information will be available for your review and staff from the Region, Cities of Kitchener / Waterloo and Consultant will be present to answer your questions. Your comments will assist the Project Team in finalizing the Recommended Design Alternative to be presented to the Region’s Planning and Works Committee for approval in early 2020.

All comments and information received from individuals, stakeholder groups and agencies regarding this project are being collected to assist the Region of Waterloo in making a decision. Under the Municipal Act, personal information such as name, address, telephone number, and property location that may be included in a submission becomes part of the public record.
