REQUEST FOR SEPARATED FAMILIES STATUS

INFORMATION FOR APPLICANTS

In order to request Separated Families status, please complete all sections of this form and attach a letter completed by Family and Children's Services of Waterloo Region who can verify that the household meets the Separated Families status criteria. If you have not already done so, you will also be required to submit an Application for Community Housing. Only those households who are eligible for Community Housing will be considered for this status.

Note: Separated Families status is not a waiting list priority but a special status. What it means is that qualified applicants will be selected from this waiting list category if there are no higher ranking priority applicants, and ahead of other non-priority applicants for every 10th offer. If an applicant with Separated Families status refuses the first offer of housing, the status will be removed and they will be placed on the regular chronological waiting list for the final two offers.

WHAT IS SEPARATED FAMILIES STATUS?

Separated Families status may be assigned to an applicant household whose children will not be returned by Family and Children's Services of Waterloo Region until adequate housing is found and housing is the only outstanding protection issue.

WHO MAY REQUEST SEPARATED FAMILIES STATUS?

Any member of a household applying for Community Housing in the Region of Waterloo, that is 16 years of age or older, may request the household be given Separated Families status. Only applicant households who satisfy the Separated Families criteria as noted above, who have resided in the Region of Waterloo for the last 12 consecutive months, exhausted their market rent housing options and have a monthly income that is less that the amounts listed below will be considered for this status.

I understand that all information I give to Region of Waterloo Co-ordinated Access System (ROWCAS) will belong to them. In situations where the member of the household will be seeking Ontario Works, the member of the household will allow ROWCAS to exchange information with Ontario Works for the purpose of verifying their eligibility for Separated Families status.

- Be eligible for rent-g geared-to-income assistance; AND
- Submit a completed Request for Separated Families status form with the verification section completed by Family and Children's Services of Waterloo Region; AND
- Meet the established criteria for Separated Families status.
