## New Dundee Water Supply – Iron and Manganese Water Treatment Upgrades

### Municipal Class Environmental Assessment

The Region of Waterloo has initiated a Municipal Class Environmental Assessment (EA) Study for iron and manganese treatment upgrades for the New Dundee Water Supply System. The New Dundee Water Supply System is located at 156 Alderview Road in the Town of New Dundee, in the Township of Wilmot. The Study will review and provide recommendations related to iron and manganese treatment upgrades based on current industry standards and new technologies, as well as the location of potential upgrades, should they be recommended.

#### How is this Study being undertaken?

This Study is being undertaken as a Schedule 'C' project in accordance with the requirements of the Municipal Class Environmental Assessment (October 2000, as amended in 2007, 2011 and 2015), which is an approved process under the Ontario Environmental Assessment Act.

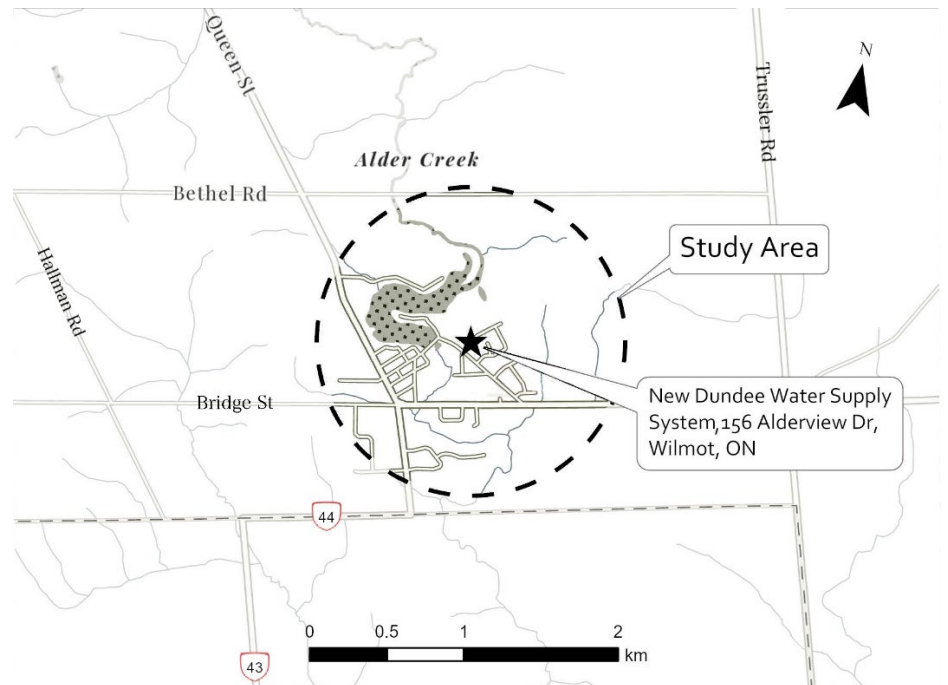


Figure 1: Study Area
