The following resolution has been submitted by MPP Michael Harris, Kitchener-Conestoga, to the Clerk's Office of the Region of Waterloo for consideration at the Regional Council meeting on Wednesday, June 5, 2013.

WHEREAS municipalities are not commercial enterprises and have a different purpose and mandate from businesses in the construction industry;

WHEREAS the Ontario Labour Relations Board treats municipalities as businesses and employers for the purpose of the construction-industry provisions contained within the Labour Relations Act, 1995;

WHEREAS an amendment to the Labour Relations Act, 1995 is needed to clarify that municipalities are not employers in the construction industry;

WHEREAS the Large Urban Mayor's Caucus of Ontario has previously requested such an Amendment to the Labour Relations Act to protect fair and open tendering for municipal infrastructure projects;

WHEREAS such an amendment would ensure the best value for infrastructure projects funded by all three levels of government;

WHEREAS such an amendment would ensure fairness for all workers, regardless of their affiliation with a particular union, by guaranteeing the right to work on publicly funded infrastructure projects;

WHEREAS such an amendment would save taxpayers money by ensuring the most qualified contractor offering the best value is awarded contracts for publicly funded infrastructure projects tendered by Ontario municipalities;

THEREFORE BE IT RESOLVED that the Region of Waterloo asks the Legislative Assembly of Ontario to amend the Labour Relations Act, 1995 to make it clear that municipalities are not construction employers.

Tenders were called for Hespeler Road and Water Street Improvements Regional Road 24, from Eagle Street/Pinebush Road to Bishop Street and Augusta Street to Ainslie Street North, City of Cambridge and were advertised in the Record, the Daily Commercial News, on the OPBA website and on the Region's website. Hespeler Road Improvements, City of Cambridge – Resurfacing of asphalt roadway, relocation of catchbasins and installation of side-inlet catchbasins, traffic signal component upgrades, bus bay removal, concrete bus shelter pad and landing pad relocation, and construction of median planting beds (which are provisional items still subject to confirmation of final details by the City of Cambridge).

Water Street Improvements, City of Cambridge - Resurfacing of asphalt roadway including small areas of full depth reconstruction, relocation of catchbasins and installation of side-inlet catchbasins.

replacement of sanitary sewer main and services and water services (on behalf of the City of Cambridge), and sections of curb and boulevard replacement.

Ottawa Street Infill Sidewalk, City of Kitchener – Construction of sidewalk on Ottawa Street west of Wilderness Drive to connect to the existing internal sidewalk.

Construction Schedule

Construction is scheduled to start in late June, will be completed by the end of September and the contractor is permitted to work simultaneously at all locations.

<u>Traffic Restrictions</u>

Hespeler Road Improvements – Hespeler Road will be reduced from 3 lanes to 2 lanes in each direction from Eagle Street/Pinebush Road to Bishop Street between the hours of 7:00AM and 7:00PM, Monday to Friday. During night paving operations between 7:00PM and 6:00AM, Hespeler Road will be reduced to one lane in each direction.

Water Street Improvements – Water Street will be reduced from 2 lanes to 1 lane in each direction from Ainslie Street to Augusta Street between the hours of 7:00AM and 7:00PM, Monday to Friday. There will be an additional lane reduction, down to one lane with traffic in each direction alternately proceeding through the construction zone with flagging, for 5 working days between 9:00AM and 3:00PM, as well as a closure of the northbound lanes between Ainslie Street and Samuelson Street for one weekend, between 7:00AM Saturday and 10:00PM Sunday.

Ottawa Street Infill Sidewalk – There will be periodic closures of one eastbound lane between the hours of 7:00AM and 7:00PM west of Wilderness Drive. One eastbound through lane and the left turn lane will be maintained at all times.

Approvals

Staff are currently awaiting Ministry of Environment approval for the replacement of the City of Cambridge sanitary sewer on Water Street, however it is anticipated that all approvals will be in place when construction is scheduled to commence.

The Region of Waterloo's approved 2013 Ten Year Transportation Capital Program includes a total budget of \$4,570,000 in 2013 for the Hespeler Road Improvements (Project #5572), Water Street Improvements (Project #5396) and Ottawa Street Infill Sidewalk (Project #5712) to be funded from the Roads Rehabilitation Capital Reserve Fund.

Based on the low tender result, the actual cost of this work is \$2,338,505, which is \$2,231,495 (or approximately 49%) under the project budget. This under-run is attributable to a number of factors which arose after the 2013 budget for these projects were finalized in the fall of 2012, as follows:

- 1. In general, the budgets for Hespeler Road and Water Street initially carried very conservative cost estimates due to uncertainties at the time regarding the scope of Rapid Transit works through these corridors; subsequent to the budgets being finalized in the fall of 2012, the project limits on both Hespeler Road and Water Street were also reduced to avoid working in areas that will require changes in the coming years for the future aBRT system; these areas will be paved in conjunction with the future aBRT work and the costs for the resurfacing will have to be budgeted for at that time in the Transportation Capital Program;
- 2. Intersection improvements at Dando Avenue were budgeted for and under consideration as part of the Water Street work but these works were ultimately deleted from the project during the detailed design phase due to property impacts and geometric considerations;
- 3. A significant amount of storm sewer replacement originally included in budget estimates was not required due to good condition of the existing sewer confirmed by video inspections which were not available due to sewer obstructions until late 2012:
- 4. Cold planing and base asphalt unit prices were lower than costs in recent years, in part due to the current extremely competitive environment for road construction contracts; and
- 5. More extensive underground work was required for the City of Cambridge on Water Street and accordingly, the top layer of asphalt on Water Street which was originally included in budget estimates will now have to be budgeted for and completed in 2014 rather than as part of this contract, to allow for any trench settlement.

The work under this contract includes:

 the construction of a grade separated railway crossing at the CN tracks north of Victoria Street;

- the widening of Weber Street from two to four lanes and re-alignment between Victoria Street and Wilhelm Street;
- replacement of storm and sanitary sewers and watermain and the installation of a 600mm diameter regional trunk watermain;
- roadworks including full depth road reconstruction, concrete curb and gutter, sidewalk and multi-use path, streetlighting, noise attenuation barriers and landscaping;
- at the proposed grade separation, additional architectural enhancements to the structure, and abutments and retaining walls;
- replacement of storm and sanitary sewers and watermain on behalf of the Cities of Kitchener and Waterloo;
- a third abutment at the grade separation and the construction of a temporary GO bus dropoff on behalf of GO Transit/Metrolinx.

Construction Schedule

This project has been designed to be constructed in three phases consisting of College Street to Wilhelm Street, Wilhelm Street to Guelph Street and Guelph Street to Union Street. The order of construction of the phases will be at the discretion of the selected contractor. Staging of construction will in general include the construction of a temporary detour road west of the proposed grade separation, construction of the grade separation, installation of undergrounds then finally construction of the roadworks. Construction is expected to start on or about June 17. 2013. The contract includes the requirement that the work must be complete by no later than November 30, 2014.

Traffic Restrictions

Two-way traffic on Weber Street will be maintained during construction. In order to maintain traffic during construction of the grade separation, a two lane detour road west of the existing right-of-way between Victoria Street and Wellington Street will be constructed. This detour will be in place for the duration of construction until traffic can be diverted back to the reconstructed Weber Street. Access to all abutting properties will be maintained during construction.

Several short duration road closures will be required during the construction in order to accommodate the staging of the works. Where possible, these will be scheduled on weekends or at night.

<u>Approvals</u>

Ministry of Environment approvals for the proposed underground infrastructure has been received. Structural approval of the design for the grade separation has been received from GEXR on behalf of CN rail which owns the tracks.

The Region of Waterloo's 2013 Ten Year Transportation Capital Program includes a total budget of \$42,815,000 (Projects #7101 and #5488) in the years 2013 to 2015 for this project funded from the Development Charge Reserve and Roads Capital Levy Reserve Funds. Based on the low tender result, the resulting total cost of \$40,997,152 represents a funding surplus of \$1,817,848 (approximately 4%).

The budget surplus on this project is attributable to lower unit prices than expected for sewers and watermain and a consequence of receiving competitive pricing from the ten bidders who submitted tenders for the work.

From approximately 100m south to 100m north of the Floradale Road Bridge, traffic will be reduced to one lane and traffic in each direction will alternately proceed through the construction zone with the use of temporary overhead/pole mounted traffic signals.

The Region of Waterloo's approved 2013 Ten Year Transportation Capital Program includes a budget of \$415,000 in 2013 for the Floradale Bridge Rehabilitation (Project #5623) to be funded from the Roads Rehabilitation Capital Reserve Fund.

Based on the low tender result, the actual cost of this work is \$671,508, which represents a budget shortfall of \$256,508 (approximately 62%). Based on the fact that the three lowest tender submissions were within 3% of each other, staff is confident that the low price is competitive and representative of current market conditions. The budget shortfall is attributable to the following factors:

- Increased demand for structural work locally by the Ontario Ministry of Transportation and the Region has resulted in some higher than anticipated structural unit costs on this contract.
- During the detailed design phase in late 2012, it was determined that additional work
 was required to the railings and wingwalls which resulted in additional costs for this
 contract. The need for this additional work was determined after the finalization of the
 budget estimate as part of the 2013 Transportation Capital Budget.

This shortfall can be funded from other capital budget transfers or from available funds in the Roads Rehabilitation Reserve Fund all of which will be identified in the mid-year review of the 2013 Transportation Capital Budget, currently scheduled to be presented to Council in June of 2013.

The scope of this contract is to construct an organics transfer bunker, public drop off bunkers, loading facility and compost pad expansion at the Cambridge Waste Management Centre. REPORT:

Proposals were called for P2013-10 Supply of Ballasted Flocculation with Sludge Thickening Equipment and were advertised in the Waterloo Region Record, the Daily Commercial News, on the Ontario Public Buyers Association website, and on the Region's website. Two proposals were received and opened in the presence of C. Melitzer, M. Darmalingum and J. Markovic.

The two proposals were evaluated using pre-determined technical criteria, including compliance with technical specifications, performance guarantees and demonstrated experience with similar installations. One proposal did not meet the minimum requirements outlined within the bid documents and their price envelope was returned unopened. The proposal from Veolia Water Solutions and Technologies Canada Inc (VWS Canada) met the Region's technical requirements and their price envelope was opened for evaluation.

The following proposal was received:

Veolia Water Solutions and Technologies Canada Inc. St. Laurent, QC \$1,887,964.45

The Mannheim WTP in Kitchener treats water from the Grand River for the supply of drinking water to the integrated urban water supply system. Process water is generated from the settling and filtering processes at the Mannheim WTP and this water is then directed to the Residuals Management Plant for treatment. The Mannheim Residuals Management Plant is located on the site of the Mannheim WTP and treats all Mannheim WTP process water. After treatment through the Mannheim Residuals Management Plant, the process water is currently directed to an on-site outdoor pond for evaporation and infiltration. The discharge of process water to the outdoor pond is not sustainable because the outdoor holding pond is reaching its capacity. The purpose of the proposed Mannheim Residuals Management Plant upgrades is to implement a long-term solution to managing process water from the Mannheim WTP by treating and recycling process water back to the Mannheim WTP for full treatment. This approach will also make more efficient use of the Region's surface water resources. A Ballasted Flocculation System with Sludge Thickening is the best treatment technology for this purpose because it is a

robust system that is compact enough to fit within the existing building and will provide the superior treatment required to recycle and re-use the process water at the Mannheim WTP. The Ballasted Flocculation System with Sludge Thickening is a very specialized technology and VWS Canada is the only known supplier that has demonstrated experience with similar installations.

The treatment system must be selected now in order to complete the detailed design of the Mannheim Residuals Management Plant upgrades. The selected treatment system will be incorporated by means of a novation agreement into a future general construction contract for the Mannheim Residual Management Plant upgrades.

The Region's consultant and staff are satisfied that the VWS Canada equipment meets all of the technical and financial evaluation criteria and that the proposed equipment is of high quality. The price is fair and reasonable and selection of the VWS Canada equipment provides the best value for the Mannheim Residuals Management Plant upgrades by providing quality recycled water with no expansion of the existing building. VWS Canada has demonstrated their ability to successfully complete a number of similar installations in Canada. VWS Canada has successfully completed a pilot demonstration of this technology at the Mannheim Residuals Management Plant.

The Ministry of Environment (MOE) has reviewed the proposed treatment technology and has issued a draft approval for the Mannheim Residuals Management Plant upgrades subject to review of the detailed design submission. An application for a City of Kitchener building permit for the Mannheim Residuals Management Plant upgrades will be submitted once detailed design is completed.

Subject to Council and MOE approvals, tender of the general construction contract is planned for early 2014. Construction of the proposed Mannheim Residuals Management Plant upgrades is expected to commence in March 2014 with completion expected in early 2015. Delivery of the Ballasted Flocculation with Sludge Thickening System Equipment is planned for April 2014 following the start of construction.

 - Establish thresholds for properties in the commercial, industrial and multi-residential classes such that if the taxes on the property calculated under the capping program are within \$250 of the current value assessment (CVA) taxes, the CVA taxes will apply;
 - c. Continue with the "Stay at CVA" option and exclude properties in the commercial, industrial and multi-residential classes that were at their current value assessment taxes in 2012 from the 2013 capping and claw back program;
 - d. Continue with one aspect of the "Cross CVA" option and exclude properties in the commercial, industrial and multi-residential classes that were subject to a claw back in 2012 from becoming a capped property in 2013;
 - e. Fund the limits on tax increases for 2013 for the commercial, industrial and multiresidential classes by limiting 2013 tax decreases for properties in the same class;

AND THAT the required by-law to establish the options for the 2013 Property Tax Capping Program be included on the June 5, 2013 Regional Council agenda;

AND THAT the required by-law to establish 2013 claw back percentages for the commercial, industrial and multi-residential classes be included on the June 26, 2013 Regional Council agenda;

That the 2013 operating budget for Emergency Medical Services be increased by \$56,400 gross and zero net Regional Levy; and

That the 2.0 FTE Non-supervisory EMS Schedulers be included in the 2014 Base Budget for Emergency Medical Services as outlined in PH-13-022, dated May 28, 2013;
