Tenders were called for the supply of Wix Filters for a five (5) year period and were advertised in the Record, on the Region's website and on the Ontario Public Buyers Association website. Tenders were opened in the presence of L. Smith, A. Albrecht and D. Schmidt.

Transaxle Parts Cambridge Inc. Cambridge, ON \$93,042.70

Britton Automotive Waterloo, ON \$96,098.35

While nine (9) bid packages were requested, only two bids were received. Some of the potential bidders were contacted to inquire why they did not bid and they cited they were not Wix distributors or felt they could not compete with some of the other bidders. The bid prices reflect the supply of approximately 7,100 filters annually.

Wix filters are an automotive filter used on transit buses and Regional vehicles. Both Fleet Services and Grand River Transit standardized the use of Wix filters a number of years ago for vehicles that do not require Original Equipment Manufacturer (OEM) parts. The work of this contract is to purchase Wix filters for Fleet Maintenance use at the Regional Operations Centre and the Grand River Transit Maintenance Facility.

Prices are firm for the first year of the contract and are subject to CPI adjustment (Ontario Consumer Price Index) for years 2 to 5.

Quotes were called for Q2015-1115 Monitoring Well Installation Program – Detweiller Transformer Station and were issued to nine (9) vendors. A prequalification was completed in January 2013 for this project (PQ2013-14) and only bids received from the prequalified list were accepted. Due to current workloads and the inclusion of a specialized geotechnical sampling component, only two (2) bidders submitted pricing for the complete work of this project.

*One (1) bid was disqualified.

The work under this contract includes borehole advancement, vertical aquifer sampling and construction of between 2 and 6 groundwater monitoring wells. This work is required to further delineate potential groundwater impacts associated with the Waterloo Landfill Site on the Detweiller Transformer Station property, owned by Hydro One Networks Inc. (HONI). The work to install the monitoring wells and complete the vertical aquifer sampling is expected to start as soon as all access agreements are completed between HONI and the Region. The Region is expecting to execute said agreements in September. The work is expected to be completed by December 2015.

The work of this contract is for the supply of coarse highway salt for winter maintenance on Regional roads. The Region's Transportation Division annual usage is approximately 15,000 to 17,000 tonnes yearly and fluctuates depending on the winter conditions.

Prices are firm for the first year of the contract and are subject to CPI (Ontario Consumer Price Index) for years 2 to 4.

The Region's approved 2015 Transportation Division budget for Winter Route Maintenance Materials is \$794,000. To date \$619,000 has been spent leaving a budget of \$175,000 for the remainder of the calendar year. Salt usage for the remainder of the year will depend on weather conditions in November and December. Assuming typical weather conditions for the remainder of the year, it is estimated that the Region could spend approximately \$200,000 on salt usage in November and December resulting in a total estimated 2015 expenditure of \$819,000 which is \$25,000 (3%) over the approved budget. Should the required spending exceed the budget, the overage would be funded from reallocations within the overall Winter Route Maintenance Budget or from the Winter Maintenance Reserve Fund which currently has a balance of \$813,000.

Based on the low tender result, the estimated annual cost of the materials is \$823,200 which is \$29,200 (3.7%) over the 2015 budget. The 2016 base budget for Winter Route Maintenance Materials will be adjusted to reflect the tender result.

The scope of work includes the upgrade of the majority or all of the existing lights within eight Region facilities:

- Region Headquarters, 150 Frederick Street
- Regional Laboratory, 100 Maple Grove

- Waterloo Landfill Education Centre, 925 Erb Street East

Staff attribute the low amount of bids to both the type of work and the time of year. Staff has reviewed the pricing submitted and feels the low bid is fair and reasonable. The work under this contract includes the following at 74 Church St. Kitchener, 31-45 Amos Ave. Waterloo and 625 Albert St. Waterloo: removal and replacement of concrete moving strips, addition of window wells, re-grading of landscape to provide positive drainage from existing structures. Current conditions exist which allows ponding to occur

against building structures or open areas within playgrounds adjacent to the existing drainage infrastructure. This work will help prevent water from migrating into the basement of various housing units through the foundation wall and basement windows.

Provisional prices have been incorporated to the base bid to complete grading improvements at 74 Church St. Kitchener and 625 Albert St. Waterloo described above. The work is expected to be completed by November 2015.

Report:

Tenders were called for T2015-124 Preston Wastewater Treatment Plant (WWTP) Odour Control Upgrades and were advertised in the Record, in the Daily Commercial News and on the Region's website.

There had been a pre-qualification completed for this project (PQ2015-05) open to General Contractors who are signatories with the Carpenters Union. Only bids received from the pre-qualified list were accepted. The pre-qualification proposals were evaluated using pre-determined technical criteria which included corporate and financial information, organization chart, experience on similar projects, staffing and subcontracting information, health and safety policies, procedure and track record, and references. Following the qualitative evaluation three (3) General Contractors were prequalified and invited to bid.

Tenders were opened in the presence of J. Markovic, M. Darmalingum, and C. Bogusat.

The work under this contract includes the following:

- Construction of new odour control building, including supply and installation of new bio-trickling filters for improved odour control of the primary clarifiers and the headworks building, with all associated yard ducting, and electrical, instrumentation and control systems (project # 08323);
- 2. Supply and installation of new full surface covers to replace the existing aging covers on the existing primary clarifiers (project # 08323);
- 3. Refurbishment of the existing primary clarifiers, including new walkways and scum baffles, and repairs to the concrete walls and launders (project # 08308);
- 4. Demolition of existing, but obsolete, sludge tank (project # 08308); and
- 5. Site improvements comprising widening of the entrance to and driveway inside the plant; supply and installation of new gates and fencing; new potable water service to the headworks building; new fire hydrant; and new fencing to the property across the road from the existing treatment plant recently acquired for future plant extensions (project # 08308).

Subject to Council approval, construction is expected to commence in October 2015 with completion expected in October 2016.

The Region of Waterloo's approved 2015 Wastewater Capital Program includes a budget of \$1,526,000 in 2015 and \$750,000 in 2016 for the Preston Treatment Upgrades (project # 08323) and \$1,200,000 in 2016 for Cambridge Infrastructure Upgrades (project # 8308), to be funded by the Wastewater Reserve Fund (76%; \$2,679,800) and Regional Development Charges (24%; \$796,200) as set out in the table below.

The cost of work is \$1,010,000 (approximately 29%) over budget. The budgeted amount was based on a conceptual design completed in 2014 and recent tenders and budgeting price information from industry suppliers. During detailed design in 2015, necessary work not included in the budget was added to the contract including an enclosure to mitigate noise from the odour control equipment and the refurbishment of existing

clarifiers 3 and 4 (built in 1967). As only two bids were received for this work, a portion of the cost overrun could be attributed to lack of competitive pricing; however, retendering under the same conditions is not expected to result in lower pricing. The work of this contract is required in order to improve odour control at the plant and to replace aging equipment.

It is recommended that the budget for Preston Treatment Upgrades (project # 08323), be increased by \$1,010,000 in 2016 to be funded by the Wastewater Reserve Fund (78%; \$789,800) and Regional Development Charges (22%; \$220,200). It is noted that two significant contracts in 2015 (T2015-104 and T2015-129) for the Kitchener Wastewater Treatment Plant Upgrades were, in total, under budget by approximately \$14 million. As well, other construction projects will be prioritized or delayed in 2016 to accommodate this increase.

The final date of acceptance for this tender is October 30, 2015.

The Region of Waterloo's approved 2015 Ten Year Transportation Capital Program provides a total 2015 budget of \$7,660,000 for these Regional Road projects of which \$724,000 is available for landscaping at the ten road project locations included in this contract. Based on the low tender result, the estimated cost of the work is \$617,500 and is to be funded from the Roads Rehabilitation Reserve Fund (54%; \$334,200), Development Charges Reserve Fund (36%; \$222,200) and the Roads Capital Levy Reserve (10%, \$61,100). The project costs are approximately \$106,500 or 14.7% under the budget amount.

Subject: Fountain Street Bridge Repairs, City of Cambridge

Summary:

Report:

The Fountain Street Bridge over the Grand River in the City of Cambridge was constructed in 1958 by the Ontario Department of Highways and later transferred to the Region of Waterloo. The concrete bridge was first rehabilitated by the Region in 1984.

In 2010, the Region retained an engineering consultant to develop plans for the next rehabilitation of the Fountain Street Bridge. Based on a detailed investigation and analysis of the bridge, the engineering consultant made the following observations and recommendations:

- (i) The bridge "superstructure" (girders, deck, sidewalks, barriers and asphalt wearing surface) was exhibiting advancing deterioration, typical for a structure of the type and age of the Fountain Street Bridge;
- (ii) It would be more cost-effective to undertake a complete removal and replacement of the entire superstructure, rather than to undertake a major rehabilitation of the existing bridge;

(iii) The existing superstructure should be inspected on an annual basis (rather than the provincially-mandated two-year cycle) in the years leading up to removal and replacement; and

(iv) Minor interim repairs should be undertaken as may be required in order to provide continued satisfactory function of the existing superstructure until it is replaced.

The complete removal and replacement of the superstructure is currently scheduled for 2017 and 2018 in the Region's approved 2015 Transportation Capital Program. The bridge work will be undertaken in conjunction with the reconstruction of Fountain Street from Blair Road to Preston Parkway. Staff will be presenting a report in the coming weeks to obtain Council approval of the recommended improvements to Fountain Street, including the bridge superstructure replacement.

2011 and 2013 Repairs to Existing Bridge

The engineering consultant recommended minor repairs in 2011 and 2013, based on areas of deterioration identified during the consultant's annual inspections. The Region retained the firm of Engineered Concrete Ltd., in accordance with the Region's Purchasing by-law, to complete the repairs at a cost of approximately \$35,000 in 2011 and \$19,000 in 2013. Engineered Concrete completed the work to a high level of quality and provided comprehensive traffic control to ensure safe passage of vehicles and pedestrians while the work was being undertaken.

2015 Repairs to Existing Bridge

In early 2015, following a comprehensive inspection and sampling program undertaken in 2014, the engineering consultant developed plans for additional deck repairs and recommended that these be undertaken in early 2015. Based on the estimated scope of deck repairs recommended, the estimated value of the repair work was below \$100,000.

The bridge construction and rehabilitation industry has experienced a high level of demand in recent years as bridge-owners work to construct new infrastructure and undertake major rehabilitation of existing infrastructure. Accordingly, Region staff has experienced difficulty in soliciting interest from qualified construction firms to undertake small bridge repair works.

In May 2015, staff contacted Engineered Concrete, the firm that had undertaken minor repairs previously in 2011 and 2013. Engineered Concrete was familiar with the bridge and the traffic staging requirements, and continued to possess the required experience and resources to complete the work. Additionally, Engineered Concrete indicated that they could commence the work immediately. Based on past experience with Engineered Concrete, staff has found their prices to be cost-competitive.

The Region normally purchases goods and services with an estimated value of between \$10,000 and \$100,000 through solicitations of competitive quotes from three or more qualified firms, and those with an estimated value of over \$100,000 through advertisement of a public tender. Part VII, Clause 21(1) of the Purchasing by-law provides that the Chief Purchasing Officer may acquire any goods or services through direct negotiation in certain situations including when:

- in the judgment of the Chief Purchasing Officer, the goods or services are in short supply due to market conditions (21(1)(b));
- the extension of an existing or previous contract would prove more cost effective or beneficial for the Region (21(1)(g)); or
- the acquisition involves the ongoing maintenance and service requirements for Regional property (21(1)(h)).

Staff assessed that it would be in the Region's interest to acquire the necessary repair works through direct negotiation with Engineered Concrete, at a cost not expected to exceed \$100,000, and retained Engineered Concrete to complete the necessary repairs.

While the original scope of work was developed through the comprehensive field inspection and sampling program in 2014, the actual extent of work required could only be determined as the asphalt and concrete removals were undertaken in affected areas. Subsequent to commencing the work, it was observed that the areas of deteriorated concrete were generally larger than anticipated, and it was determined that the cost of the repairs would likely exceed \$100,000. Although Part VII, Clause 21(2) of the Purchasing by-law requires the Chief Purchasing Officer to submit any negotiated acquisition to Council for approval if the value of the acquisition exceeds \$100,000, the repair work could not be halted once started and had to continue expeditiously to completion, without delay, at all affected locations, in order to ensure continued safe operation of the bridge and to limit disruption to traffic.

Purchasing by-law, Part VIII, Clause 22(1) states that the Chief Purchasing Officer may acquire any goods or services that are required by the Region to respond to a situation where the immediate purchase of goods or services is essential to comply with any law, regulation or lawful order or to prevent delays in the work of any Department which might involve danger to life, damage to property or the provision of an essential service. Purchasing by-law, Part VIII, Clause 22(3) states that any authority under this section shall include the authority to sign any contract or other document that may be required as part of the acquisition of the goods or services. In addition, Ontario Regulation 104/97 states that "every bridge shall be kept safe and in good repair."

Given all of the legislative provisions and Purchasing by-law requirements listed above, staff assessed continuation of the repair work was necessary in order to ensure continued compliance with Ontario law, to prevent danger to the traveling public, and to maintain the essential service provided by the bridge. Accordingly, staff directed Engineered Concrete to complete the required repairs.

The required repairs have now been completed and the final total value of the work is \$135,403.43 plus applicable taxes. The engineering consultant believes that the 2015 repairs should be sufficient to provide continued satisfactory operation of the bridge superstructure until dismantling and replacement starting in 2017, and provide a sound working deck surface and overall structural strength required to permit heavy demolition and construction equipment to systematically dismantle the bridge without impacting the Grand River.

Purchasing by-law, Part VIII, Clause 22(1) requires that the Chief Purchasing Officer report to Council any expenditure made under Part VIII with a value in excess of \$100,000, including an explanation. This report is provided to fulfill this requirement.
