# **Delegations**

- TES-WMS-15-02, Woolwich Transfer Station Response to Resolution from Township of Woolwich
  - i. Patrick Merlihan, Township of Woolwich Councillor, appeared before the Committee noting that the Township does not want to see the transfer station close. He provided background information and stated that during the last election the closing of the transfer station was the main topic of concern. He referred to the recommendation that the Township of Woolwich passed asking to allow for the sale of the transfer station to a private operator and the Region continue service at the transfer station until the private operator has all the necessary approvals. He provided the benefits of the sale asked that the Region move forward to allow for this business opportunity.

Jon Arsenault, Director, Waste Management, introduced the report highlighting that the rural transfer stations are scheduled to close March 2015. He pointed out the primary concerns with the Township of Woolwich recommendation regarding the sale to a private operator. He stated that Regional staff is recommending that no action be taken with respect to the Township of Woolwich's resolution and noted that the report identifies an alternative option for consideration.

Thomas Schmidt, Commissioner, Transportation and Environmental Services, pointed out the goal for the alternative option is to allow staff time to continue to monitor on site

usage and actual cost recovery and report back to Council as part of the 2016 budget process.

Craig Dyer, Chief Financial Officer, provided clarification on the waste management budget, highlighting that the budget book contains the \$2.00 fee but that there is a budget issue paper for Council to consider an increase charge from \$2.00 to \$5.00. He also pointed out that the 2014 waste management budget included the full year of all the transfer stations and the 2015 budget only accounts for the first 3 months.

A Committee member pointed out that the rural transfers are not equipped to handle the ICI waste and highlighted curbside pick up in the townships.

The Committee discussed the sale of the transfer stations and asked that staff report back with implications on the tax levy due to the potential lack of ICI tonnage, the environmental and legal implications of contamination, what the Region is paying in the current contract and if the fees charged at a private transfer station will be comparable to the Region's fees. Committee members directed Region staff to explore the potential sale of the rural transfer stations and to meet with potential purchasers to discuss their business plans.

S. Strickland brought forward a motion to defer the report until the next budget meeting to allow staff time to report back with financial information regarding keeping the four transfer stations open past March 2015.

# **Community Planning**

b) PDL-CLP-15-07, Balancing Environmental Protection and Transportation Considerations: The Laurel Creek Headwaters Environmentally Sensitive Landscape Case Study

Rob Horne, Commissioner, Planning, Development and Legislative Services introduced the report noting that Regional Council endorsed an initiative to examine how best to balance transportation and environmental considerations in Environmentally Sensitive Landscapes (ESL). He stated this study was originally recommended by the Laurel Creek Headwaters ESL Public Liaison Committee and Regional staff has subsequently initiated a case study focusing on the Laurel Creek Headwaters ESL.

Some Committee members pointed out the difficulty of finding a balance on Wilmot Line and highlighted the need for traffic calming.

d) PDL-LEG-15-13, Authorization to Expropriate Lands (2nd Report) In the City of Kitchener Designated as Phase VI of Stage 1 of the Rapid Transit Project Relating to Property and Interests Located at Various Locations Along or Near the CN Railway Line Corridor, known as the Huron Park Spur, in the City of Kitchener, in the Regional Municipality of Waterloo

That The Regional Municipality of Waterloo approve the expropriation of lands for the construction of part of Phase VI of Stage 1 of the Rapid Transit Project comprised of property and interests located at various locations along the Light Rail Transit alignment in the City of Kitchener, in the Regional Municipality of Waterloo as detailed in Report PDL-LEG-15-13 dated February 3, 2015 and more specifically listed below:

### **Fee Simple Partial Takings:**

- Part Lot 8, Plan 870, being Part 7, 58R18182, Part of PIN 22599-0041(R), City of Kitchener, Regional Municipality of Waterloo (Part of 2 Hoffman St., Kitchener, Ontario N2M 3M4);

And that staff be instructed to register a Plan of Expropriation with respect to the said properties, or such lesser portions or interests of any of the said properties as may be determined through the design process, within three months of the granting of approval to expropriate said properties, in accordance with the "Expropriations Act" (Ontario) (the "Act");

And that the registered owners be served with a Notice of Expropriation and a Notice of Possession with respect to the said properties after the registration of the Plan of Expropriation and the Regional Solicitor is authorized to take any and all actions required to enforce such Notices including but not limited to any application pursuant to Section 40 of the Expropriations Act;

And that if no agreement as to compensation is made with an owner, the statutory Offer of Compensation and payment be served upon the registered owners of applicable properties in the amount of the market value of the interests in such lands as estimated by the Region's appraiser in accordance with the Act;

And that all above-referenced lands situated adjacent to an existing Regional public highway shall be acquired for road widening purposes and shall be deemed to form part of the adjacent public highway in accordance with subsection 31(6) of the Municipal Act, 2001, S. O. 2001, c.25;

And further that the Regional Solicitor be authorized to discontinue expropriation proceedings or any part thereof, in respect of the above described lands, or any part 1799388

thereof, upon the registration on title of the required documentation to complete the transaction or if determined by the Commissioner of Transportation and Environmental Services that such lands, or any part thereof, are not required for the subject Project. [PDL-LEG-15-13]
