Re: Contract T2024-133 Fountain Street & Maple Grove Road Roundabout, City of Cambridge

Regional Sewer and Watermain continues to make progress on Contract T2024-133 Fountain Street & Maple Grove Road Roundabout. The purpose of this notification is to provide the update that the project will **switch from Stage 1B to Stage 2 on the weekend of July 27th and 28th**. A full closure of Fountain Street & Maple Grove Road intersection will be required to complete this switch. This full closure is scheduled to occur after 1:30am on Saturday July 27th until 10:00pm on Sunday July 28th.

Working Hours

Normal working hours are Monday to Friday from 7:00 a.m. to 7:00 pm. Occasional Saturday work and weekend work may occur from time to time.

Traffic Restrictions during Construction

Traffic will be restricted to a single lane in each direction on both Fountain Street and Maple Grove Road during for every stage of construction within the project limits. Also, an additional left turn lane will be available on each leg of the intersection for every stage of construction. Please refer to the Staging Plan available on the website for additional details.

Traffic Detours

Traffic detours will be implemented only during full closure of the Fountain Street & Maple Grove Road intersection during the weekend of July 27th and 28th. Please refer to the planned detour route available on the website.

Access to Businesses and Residences

Access to businesses and residences within the construction limits will be maintained to the greatest extent possible; however, disruptions will occur when construction activities are being completed directly adjacent to an entrance. The Contractor will provide as much notice as possible to businesses and residences when construction activities are occurring adjacent to a property. If construction activities will make it such that you are unable to access your driveway for a short duration (including overnight), you will be directed to an alternate access.

There may be periods of time when traffic will need to travel on a gravel surface, as well as times when traffic will need to be controlled with flag persons. Temporary signage indicating businesses are “Open and Accessible” will be provided for all businesses within the active stage of construction. Please plan for some delays and travel carefully through the construction zone. We request that when driving or walking through and around the construction zone you follow and obey the construction traffic signage for your safety and for the safety of the workers.

Grand River Transit Service Changes

Grand River Transit vehicles may need to be rerouted. Please refer to the GRT website for the most current information on transit routes.

Garbage and Recycling (for properties within the active construction limits only)

During construction, for those properties that receive curb-side collection, we urge that you place your garbage in disposable bags (please avoid use of containers) at the curb along with your blue box, green bin and yard waste prior to 6:00 A.M. on your normal collection day. The garbage and recycling materials will be taken by our contractor to adjacent side streets for pickup by Waste Management. Blue boxes and green bins will be returned by day’s end. Please clearly mark your address number on your blue box and green bin to ensure proper return. Canada Post Mail Delivery (for properties within the active construction limits only)

Properties that receive door service mail delivery should not be affected while construction is taking place. Restoration and Landscaping

The work on this project includes the reinstatement of driveways, sidewalks and any landscaping that is affected by the work. Only the affected portion of a driveway will be replaced/reinstated.

The Contractor will take care of any sod we replace for 60 days. After 60 days, all sod maintenance and watering becomes your responsibility, as it was prior to construction.

Vibration, Dust, Mud

You may feel slight vibrations from the construction work. All efforts will be made to minimize adverse impacts from the construction including dust, mud and vibration.

Management of Contaminated Material

As part of the construction contract, the Contractor will be removing known contaminated soil within the project limits. Proper measures will be in place by the contractor to safely remove,

store and truck away the contaminated soil. Staff on site will have appropriate personal protective equipment when in proximity to contaminants. The nature of the contamination is mainly associated with petroleum fuel and salt residual.

The contractor and consultant will be continually monitoring air quality and utilizing dust control methods, however, residents should expect occasional odours.
